#### Summary of test results:

The members present of THE ASSOCIATION OF HUNGARIAN INSURANCE COMPANIES, PROPERTY PROTECTION AND AVERAGE PREVENTION COMMISSION (hereinafter referred to as: MABISZ VKB) have taken insight into documents submitted, studied the characteristics and technical parameters of strong boxes shown, examined their construction and considered the prescriptions of safe deposit recommendation by MABISZ, proceeded to the perusal of expertise.

### **Insurer's guarantee conditions:**

- safe deposit furniture shall operate with an opening facility of two-feather key or three dial lock completed by an emergency opening facility with two-feather key;
- The inside door or cover of deposit furniture shall bear an individual ID.-sign which shall include:
  - Name and identification of manufacturer;
  - Designation of norm and safety degree;
  - Year of production;
  - Type and serial number of product:
  - for wall safe:
  - special reinforced concrete (category D): reinforced on all sides with a minimum thickness of 30 cm (20 cm on the backing) in 10x10 cm spacings, reinforced with a 5 mm iron mesh offset in a C 30 rated concrete bed, fixed in a structural support element:
  - reinforced concreting (category C): anchoring in a building structure support element in a 10x10 cm grid, reinforced with 5 mm iron mesh offset by at least 30 cm (20 cm on the backing) on each side, in a concrete bedding of C 12/15;
  - normal concreting (category B): installation in a minimum thickness of 10 cm on all sides in a C 12/15 concrete bedding in a structural support element;
- Safe boxes (categories A to D) shall be fixed to the load bearing structure of building to withstand a bar down force of 5 000 N (500 kg with weight of safe box);
- Strong boxes (categories E to O) shall be fixed to the load bearing structure of building to withstand a bar down force of 10 000 N (1 000 kg with weight of strong box);
- In case of an expert workmanship connection to an electronic signalling system (sensors of opening, of body sound and of drilling), the limit guaranteed by insurers for safe deposit boxes of categories A to G shall be doubled; from category I on, the expert workmanship connection to an electronic signalling system shall be compulsory;
- Submittal of documents stating to have the manufacturer's installation prescriptions, or an equivalent technical solution approved by MABISZ - of incorporation respected;
- Symbol of integrated product:  $x = \dots$  in case of a product with individual size, the exact size shall be added by the setup provider;
- The actual Table of "Guarantee Limit Recommendations regarding Safe Deposit Boxes for Insurers" shall form integrate part of this MABISZ Product Conformity Recommendation.
